- 5. Quotations must be valid for a period of 45 days after opening of sealed quotations and must be accompanied by Cash security or Bank Guarantee, amounting as mentioned above, which shall be valid for 75 days after opening of the Sealed Quotations.

If bidder wishes to submit the cash security, the cash should be deposited in Jhimruk Dharauti khata No. 0750100000136201 of Jhimruk Rural Municipality, Office, of the rural municipal executive Bhyagute, Pyuthan in the Citizan International Bank Limited, Jhimruk Branch and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
- 7. Sealed Quotation shall be opened in the presence of supplier's representatives who choose to attend at above mentioned date and time at the office of Jhimruk Rural Municipality.
